# **DIRECTOR OF MEDICAL EDUCATION AND RESEARCH, MUMBAI**

## **P.B.B.Sc NURSING –2014**

### **1) INTRODUCTION :-**

1.1 The Government of Maharashtra has decided to procure P.B.B.Sc Nursing 2 Years degree course for the Government as well as private candidates who desire to pursue the course. The procedure selection is merely on the basis of merit and the criteria for reservation laid down by the Government of Maharashtra .

### **1.2 *OBJECTIVES* -**

This process of selection is meant for selection of aspiring candidate who desire to do the P.B.B.Sc Nursing 2 Years course for the academic year 2014-2015 under establishment of Director of Medical education & Research, Mumbai. Government of Maharashtra.

### **1.3 *DEFINITIONS***

***Competent Authority:*** – Means Joint Director (Medical ) Directorate of Medical Education & Research, Mumbai 400008. Government of Maharashtra who will pursue the Selection of P.B.B.Sc. Nursing Course of 2 years duration in the State of Maharashtra for the Academic Year 2014-2015 at Institute Of Nursing Education ,Bai Motlibai Building ,Sir JJ Hospital Campus , Byculla Mumbai.

### ***Appointed Competent Authority by the DMER for the purpose of Admission process. :-***

Means The principal of Institute Of Nursing Education, Bai Motlibai Building, Sir JJ Hospital Campus , Byculla Mumbai, will be known as Appointed Competent Authority by the DMER will be responsible to carry out the directions and instructions of the Competent Authority for the selection process of P.B.B.Sc 2 years degree course under establishment of Director of Medical education & Research, Mumbai. ie. distribution and receiving of brochures and admission forms, scrutiny , preparation of merit list etc. and look after all the legal matters arising during or after the selection process for the admission Government of Maharashtra.

### **SELECTION PROCESS :**

The selection process will be conducted on the basis of merit and reservation criteria laid down by the Govt. of Maharashtra .

### **3)GRIEVANCE REDRESSAL COMMITTEE: -**

A Grievance Redressal Committee will be constituted at DMER , ST.Georges Hospital Compound opp Govt. Dental College Building Near Chatrapati Shivaji terminus (CST) Mumbai- 400001

If there is any grievance due to administrative error or any other related important matter the candidate will report it to the committee. The committee will examine the Grievance/s and take necessary decision regarding the Grievance/s.

**4) ELIGIBILITY CRITERIA FOR P.B.B.Sc NURSING - 2014:-**

- 4.1 Candidate must be an Indian National. Nationality Certificate issued by District Magistrate or Additional District Magistrate or Chief Metropolitan Magistrate or valid passport.  
Persons of Indian Origin (PIO)/Non Resident Indians. (NRI) Overseas Citizens' of India are not eligible.
- 4.2 All candidate must have passed General Nursing & Midwifery Course from Institution situated in Maharashtra and recognized by Indian Nursing Council, Delhi, as well as Maharashtra Nursing Council, Mumbai.
- 4.3 Candidate should have M.N.C. Registration Certificate / Receipt with recent renewal date valid upto 2017.
- 4.4. Eligibility for study leave :-A Candidate who has completed his/her 5 year of government service including only maternity leave. His /her 5 years service period should be completed on or before 1July2014.
- 4.6.**AGE** :- Age Limit is 40 years on or before 1<sup>st</sup> July 2014. 5 years Of age relaxable to reserve category candidate .

**5) CONDITIONS FOR GOVT. CANDIDATES:-**

- A) Only 10 seats are available for DMER, 10 seats for DHS and 10 seats are for private candidates.
- B) No Objection Certificate is mandatory of respective institute where in-service candidate is working.
- C) Candidate who is working in State Government of Maharashtra should submit their forms through Dean /Superintendent/ Matron of their respective institutes and authority's recommendation is mandatory
- D) Candidate should have completed his/her 5 years of Government service including only maternity leave. His/her 5 years service period should be completed on or before 31July 2014.
  
- E) The candidates those who are selected for P.B.B.Sc. Nursing Course have to submit 5 Years Service Bond to the Government at the time of Admission.
- F) Govt. Candidates have to submit the undertaking that after completion of their P.B.B.Sc. Nursing, they may be placed anywhere in the State of Maharashtra as per service requirement.

## **9. PREPARATION OF MERIT LIST AND DECLARATION OF RESULT**

9.1 The Competent Authority will display the merit list on or before 25/07/2014

9.2 Preparation of Merit List for Selection on the basis of marks obtained by the candidate in GNM Nursing which will be prepared in descending order of merit.

### **9.3 TIE BREAKERS :-**

In case of equal corrected marks, the following procedure shall be adopted

**FIRST LEVEL** :- A Candidate with aggregate higher Marks in GNM

**SECOND LEVEL** :- A candidate with aggregate higher marks in HSC 12<sup>th</sup> Standard preferably science stream and PCBE Marks shall be preferred if the tie still persists then:

**THIRD LEVEL** :- A Candidate with aggregate higher marks in S.S.C. or equivalent examination shall be preferred, if tie still persist then:

**FOURTH LEVEL** :- An older candidate shall be preferred over a younger candidate

9.4 Selection list will be displayed at Institute of Nursing Education, Bai Motlibai Building, Sir J.J. Hospital Campus, Byculla, Mumbai on 25/07/2014 (11.am to 4.00 pm.)

9.5 The Rules and Regulations/procedures stated herein is applicable for P.B.B.Sc. Nsg. Courses for the academic year 2014-2015 only. No promise is implied herein for the subsequent years and no expectations should be based on this for future.

## **10. CONDUCT AND DISCIPLINE**

10.1 Failure of the candidate in making full and correct statements in the application form and/or suppression of any information would lead to disqualification of the candidate or even at later date. Such a candidate will be debarred from the Selection process.

10.2 Adopting a unfair means or engaging in malpractice shall render a candidate liable for punishment under, "Maharashtra Prevention of Malpractices Act, Universities, Boards and Other Specified.

10.3 If any person(s) or officer(s) dealing with the conduct of the selection process he/she shall be liable for prosecution under Indian Penal Code.

10.4 Any candidate responsible for lapse of seat will have to pay a penalty of Rs.1,50,000/- (Rupees one lakhs fifty thousand only).This is applicable for private as well as Government candidates . Even this is applicable for the candidates resigning a seat after cut of date for P.B.B.Sc Nursing course or also fails to complete the course. Excluding suffering from serious illnesses like cancer or serious type of tuberculosis on approval of Government

10.5 The penalty for laps of seat , resigning a seat after cut-off date or fails to complete the course have to pay at "Principal INE Mumbai".

10.6 After completion of P.B.B.Sc Nursing candidate from Government sector should submit 5 years service bond to the Government. If the candidate fails to serve , they will have to pay Rs. **10,00,000/- (Rupees Ten lakhs only)** with current bank interest. Then only they will be relieved from the Bond.

10.7 Candidate seeking admission will have to Pay the Fees as per government fee structure.

## **11. LEGAL JURISDICTION :-**

a) All disputes pertaining to the selection process shall fall Within the jurisdiction of Courts, at Mumbai only. The Competent Authority shall be the legal person in whose name the candidate may sue Or may be sued.

b) Any issue not dealt here-in above will be dealt with, when arising, fully and finally by the Competent Authority. Any amendments made by Government of Maharashtra from time to time will be implemented.

### CONSTITUTIONAL RESERVATIONS

1) The candidate recognized by the State of Maharashtra as belonging to the following , categories shall alone be eligible to claim admissions as against the seats reserved for such categories. These categories are as follows:-

2) Candidates belonging to aforesaid categories will be required to submit the Caste Certificate and the Caste/Tribe Validity Certificate.

4) The candidates who have claimed the Constitutional Reservation in the original Application Form must submit Caste Validity Certificate at the time of counseling. Failing which the category claim, will not be granted and treated as open category.

A candidate belonging to 'Creamy Layer' amongst the categories 3,4,5,6 and 7 must note that the provision of reservation is not applicable to him/her. A candidate claiming benefit of reservation under the Categories 3,4,5,6 and 7 above will be required to produce Non-Creamy Layer Certificate in the name of parent as specified in the Government resolution No.सीबीसी-१०/२००८/प्र.क्र.६९७/मावक, दिनांक १३/०१/२००९- The certificate stating that it is valid upto 31/03/2015 should be submitted at the time of counseling. **ANNEXURE – "B"**

**PERSON WITH DISABILITY (PWD)**

- 1) Following are the criteria for reservation under Person With Disability Category.  
3% seats of the annual sanctioned intake capacity shall be filled up by candidates with locomotory disability of lower limbs between 50% to 70%. Provided that in case any seat in this 3% quota remains unfilled on account of unavailability of candidates with locomotory disability of lower limbs between 50% to 70% then any such unfilled seat in this 3% quota shall be filled up by persons with locomotory disability of lower limbs between 40% to 50%.  
Provided further that this entire exercise shall be completed as per the statutory time schedule for admissions. in any case no admission will be made after cut-off date.
  
- 2) The Candidate with a disability more than 70% will not be eligible for admission to P.B.B.Sc Nsg. Courses. No other disability shall be allowed. However, such a candidate will be required to undergo medical examination by a Medical Board constituted for this purpose by the Competent Authority. The Medical Board will ascertain and certify the disability and will also ascertain and certify that he/she is physically fit to undergo the course despite the disability.
